## Memorandum of Understanding

This Memorandum of Understanding is entered on \_\_\_\_ this day of 2020 by and between Guru Gobind Singh Indraprastha University, Delhi a state affiliated university having its head office at Sector 16 C, Dwarka, Delhi, 110078 hereinafter referred as **GGISP University/ Party of the First Party**

And

**M/s ENSVEE** a firm registered under a sole proprietorship Act, having its registered office at RZ-45, Sukhi Ram Park, 110059 Delhi (hereinafter referred as **ENSVEE/ Party of the second Party**).

Both **GGSIPIU** and **ENSVEE** are individually referred as "**Party**" and collectively referred as "**Parties**"

**WHEREAS** GGSIPU is a state university having several colleges affiliated to it with thousands of students graduating in different courses in the Delhi/NCR area.

**WHEREAS** ENSVEE is a firm aimed at providing assistance in training and placement activities of the college through technology.

**WHEREAS** ENSVEE has approached to the GGSIPU with its software/online platform to enable its current students to seek placement and job opportunities from GGSIPU with the use of their software through the mode of website and app.

Now both the Parties have mutually decided to enter into this Memorandum of Understanding / **MOU** for smooth and effective running of the operations/placement drive on below mentioned terms and conditions:

### 1. Objective:

1.1 The sole objective of this Agreement is that the GGSIPU by using the services and technical know-how of the ENSVEE can smoothly conduct its placement drives for its existing students.

### 2. Obligation and Duties of GGSIPU:

2.1 To permit ENSVEE to collect directly from the students, an yearly subscription fee of their app, amounting to **Rs. 100 per student excluding GST**.

2.2 To provide unhindered and as much possible access to the ENSVEE of all the placement related data/ statistics.

2.3 Shall ensure that due consent shall be taken from all the students before sharing their information/ data to any third person

2.4 GGSIPU undertakes that the services subscribed by it under this Agreement are solely for the purpose of its proper appropriation to the students and not for any commercial use/resale purpose .

### 3. Responsibilities of ENSVEE

3.1 It is ENSVEE's responsibility to provide the software application to operate the placement drives.

3.2 ENSVEE to the best of its abilities will try to make available opportunities from companies and firms for the students subscribing to their app.

3.3 ENSVEE will take steps in creating awareness through various means thereby resulting into increased chances of placement of the students.

3.4 ENSVEE will provide the mobile application to students where students can manage and access all placement activities.

3.5 ENSVEE will handle the database of students for conducting placement drives and further development.

3.6 ENSVEE will make itself unilaterally available for resolving all/any issue with the said software operation.

3.7 ENSVEE shall ensure that adequate security measures are taken at its end for data security and privacy of the students at its database.

3.8 ENSVEE shall not transfer or assign the database by either the students or by GGSIPU to any other agency without prior permission of the concerned student/GGSIPU as the case maybe .

#### 4 Responsibilities of Both the Parties:

4.1 Both the parties will review and evaluate the outcomes of joint activity at the end of each academic year and shall make recommendations for the further development and or terminate the contract.

4.2 Both the Parties shall ensure that the usage of the placement software of the ENVSEE by the Students is on Voluntary basis and shall at no stage be mandated for students to use the same.

4.3 Both the parties are responsible for doing research activities. However, ENSVEE will be actively involved.

4.4 Both ENSVEE and GGSIPU shall ensure that process of placement should be fair and transparent

4.5 Use of name, logo, and/or official emblem of any of the parties on any publication, document and/or paper is allowed only, after seeking explicit prior permission in writing by either party.

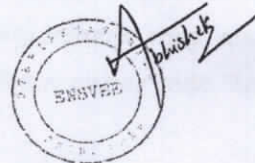
4.6 In order to carry out and fulfill the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities.

4.7 Each party agrees that it shall not, at any time, after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of business or method of carrying on the business of the other without consent of both parties.

4.8 The MOU is not intended to create any legal relation of employer-employee or of principal and agent amongst the parties.

4.9 The MOU may be extended provided the parties agree upon and can provide the necessary resources.

## 5. Mechanism of the Payment of Subscription Fee

ENSVEE, as mentioned above shall collect a nominal subscription fee of Rs 100 exclusive of GST from each willing subscriber/student (annually) availing its placement services through digital platform namely Razorpay. Every subscribing student shall also receive a receipt (digitally created) for the payment made to the ENSVEE for availing its services.

GGSIPI shall neither have any role in collection of the Subscription fee nor shall be construed as guarantor/ agent/principal of the ENSVEE or its services.

## 6. Modification of Agreement:

Revisions or modifications may be proposed at any time, which will be effective only, after mutual agreement between both the parties.

## 7. Indemnification

ENSVEE shall indemnify the GGSIPU in case of any loss, damage, penalty imposed on the GGSIPU due to leak of any confidential information/data of any student from the ENSVEE. However, it is to be specified herein that ENSVEE shall not indemnify GGSIPU or any of its affiliates for any leak of information in the following cases:

- The said information was mandated by law to be given to any law enforcing agency.
- The said information/data was provided to any 3<sup>rd</sup> Party with the written consent of the respective student/ GGSIPU
- The leak of information did not take place from the Envees's placement platform.

## 8. Duration of MOU:

6.1 This Agreement is valid for 1 year for software application.

6.2 The partnership covered by this MOU shall terminate upon completion of the agreed upon period. The agreement may also be terminated with a written one-month notice from either side. In the

event of non-compliance or breach by one of the parties of the obligations binding upon it, the other party may terminate the agreement with immediate effect.

#### 9. Dispute Resolution


Every dispute arisen between the Parties shall first be resolved through talks of negotiation between the Parties. If Parties fail to settle the dispute among themselves through talks of Negotiation, then the said dispute shall be adjudicated as per the provisions of the Arbitration and Conciliation Act (as amended till date). The Arbitral Tribunal shall comprise of a Sole Arbitrator mutually appointed by the Parties. The Venue of the Arbitration shall be Delhi and language of the Arbitration shall be English.

#### 10. Effective Date:

This Agreement becomes effective from the date of signing of this MoU.

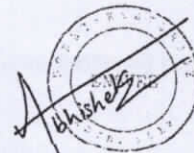
