The Schedule for **SPOT ROUND 1 COUNSELLING** to fill the seats remained vacant arising due to non- reporting of candidates in their allotted college, unfilled / un-allotted seats, withdrawal etc, is given in the succeeding paras.

I) Who are eligible for Spot Round 1 Online Counselling:

ADMITTED CANDIDATES:

1. A candidate who was allotted a seat In the Online Counselling, paid the requisite Part Academic Fee 96,000/- and reported at the allotted college/Institute in the notified data & time.

NOT ADMITTED CANDIDATES:

- 2. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fes of Rs. 96,000/- but did not report at the allotted college/institute in the notified date & time.
- 3. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 96,000/- and subsequently withdrawn as per procedure.
- 4. A candidate who was allotted a seat in the Online Counselling but did not pay the requisite Part Academic Fee of Rs. 96,000/-
- 5. A candidate who has not been allotted any seat in any rounds of the Online Counselling.
- 6. All the candidates

i) who have neither paid the Application Fee of Rs. 1500/- nor paid the Counselling Participation Fee of Rs. 1000/-

- ii) who have paid the Application Fee of Rs. 1500/-, however, not paid the Counselling Participation Fee of Rs. 1000-
- who have paid the Application Fee of Rs. 1500/- and Counselling Participation Fee of Rs. 1000/-, however, have not filled choices.
- 7. All "Not Admitted candidates.
- 8. Allotted candidates who had chosen Freeze/Float options.

II) Spot Round 1 Counselling Procedure:

- Registration for SPOT ROUND 1 COUNSELLING will be for all CET 2024 qualified candidates/ National Level Test qualified candidates respective of his/her registration earlier.
- ii) All the already Registered candidates and registering afresh will be allowed to login after accepting the terms and conditions of SPOT ROUND 1 COUNSELLING.
- iii) CANDIDATES DESIROUS OF PARTICIPATING IN THE SPOT ROUND 1 COUNSELLING ARE REQUIRED TO FILL FRESH CHOICES. All choice/preferences filled in the previous rounds of counselling shall be nullified.
- iv) The candidates who have reported at their respective School of Studies/Colleges/institution after seat allocation upto Sliding Round, if participating in the SPOT ROUND 1 are assured that if any of the new preferences filled in in the Spot Counselling is not allocated to them, THEIR EXISTING ALLOCATION OF SEAT SHALL BE RETAINED AND SHALL NOT CHANGE.
- v) The candidates who have reported at their respective School of Studies/Colleges/Institution after seat allocation upto Sliding Round, if participating in the SPOT ROUND 1 and if any of the new preferences filled is allocated to them in the Spot Round of Counselling then, the candidate SHALL BE ABIDE TO TAKE THE NEW ALLOCATED SEAT AND THEY WILL NOT HAVE ANY CLAIM ON THE PREVIOUS SEAT.



IMPORTANT NOTE:

- a) All the candidate are hereby informed that who have been allotted seat in the previous rounds of online and had paid the Part Academic Fee and wish to participate in the SPOT ROUND 1 online Counselling their Part Academic Fee paid in the earlier rounds of online counselling will be adjusted during the Spot Round of Online Counselling. Such candidates, if allotted a seat in the SPOT Round of online counselling need not to pay the Part Academic Fee again.
- b) Admitted Candidates who are allotted an upgrade Seat in the SPOT ROUND 1 online Counselling needs to pay an additional amount of Rs. 5000/- at the newly allotted Institute at the time of Physical Reporting.
- c) The upgraded candidates have to pay the balance amount of fees (if any), at the newly allotted c college/Institute/University School. The balance fee paid by such candidates in their previously allotted/reported college/institute shall be refunded to them by the respective college/institute with immediate effect. All the affiliated colleges are directed to comply with this direction.
